❖ **CONSIDERATION OF PROPOSALS**

After the proposals are opened and read, they will be compared based on meeting the requirements and being the lowest responsible bidder. The results of such comparisons will be available to the public.

The right is reserved to reject any or all proposals, to waive technicalities, or to advertise for new proposals, if in the judgement of the AUTAUGA COUNTY COMMISSION, the best interest of the County will be promoted thereby. No bid proposal shall be withdrawn within 10 (ten) days of the date of opening.

❖ ***AWARD OF CONTRACT**

The award of the contracts if to be awarded, whether bid individually or in combination, will be made within 10 (ten) calendar days after opening of proposals to the lowest responsible bidder, whose proposals comply with all applicable requirements. Should no award be made within 10 (ten) days, all proposals will be rejected, unless the successful bidder agrees in writing to a stipulated extension in the time limit for the award. The successful bidder will be notified by letter mailed to the address shown on his proposal or by e-mail that his bid has been accepted.
