Proclamation for H.O.M.E.S. Day Home Ownership Means Economic Success

Whereas, Delta Sigma Theta Sorority, Inc. was founded on January 13, 1913 on the campus of Howard University, and is an organization of college educated women committed to the constructive development of its members and to public service with a primary focus on the Black community; and

Whereas, the sorority is a private, not-for-profit organization whose purpose through programs is to aid and support local communities throughout the world; and

Whereas, the sorority currently has 1,000 collegiate and alumnae chapters around the world, with three [the Montgomery (Alabama) Alumnae, Beta Eta, and Omicron Mu) chapters serving the tri-county area (Autauga, Elmore, Montgomery); and in recognition that the Montgomery (AL) Alumnae Chapter and the Beta Eta Chapter were both chartered in 1937, celebrating 85 years of service; and

Whereas, Marcia L. Fudge, the 21st National President of Delta Sigma Theta Sorority, Inc., is the 18th Secretar of the U.S. Department of Housing and Urban Development, the chapters support HUD's mission to create strong, sustainable, inclusive communities and quality affordable homes for all; and

Whereas, after a review of the National Association of Realtors® (NAR) 2022 Snapshot of Race and Home Buying in America report, which examines current racial disparities in the housing market, Secretary Marcia L. Fudge stated that black homeownership remains lower than a decade ago, despite the U.S. homeownership rate experiencing largest annual increase on record; and

Whereas, several proactive steps have been taken to redress the impact of past discriminatory practices and implement new policies to help more families—particularly African Americans—realize the dream of homeownership. One step included funding to HUD-approved housing counseling agencies that are partnering with Historically Black Colleges and Universities (HBCUs), Hispanic Serving Institutions (HSIs), or other Minority Serving Institutions (MSIs). This funding will support housing counseling agencies in their work to help families make more informed housing choices. The awards also include funding to further training and education to attract and retain more diverse housing counseling professionals.
