WHEREAS, the Autauga County Commission, as a governmental agency within the State of Alabama, has access to funding assistance made available under the Coronavirus Aid, Relief, and Economic Security Act of 2020 (CARES Act) which provides for a supplemental appropriation of Community Development Block Grants as authorized by the Housing and Community Development Act of 1974, as amended, and as administered through the Alabama Department of Economic and Community Affairs (ADECA), as long as certain thresholds are met for program eligibility; and

WHEREAS, the County often requires professional engineering and/or architectual assistance in preparing preliminary information required in CDBG grant applications as well as final design and inspection services for any successfully awarded CDBG grant; and

WHEREAS, the Autauga County Commission is a member of the Central Alabama Regional Planning and Development Commission (CARPDC) that provides its member governments with a broad range of programs and services; and

WHEREAS, CARPDC solicited engineering and architectual proposals on behalf of its member governments in order to establish a Qualified List of Engineers and Architects that may be used by its member governments in the Central Alabama Region to work on CDBG related projects; and

WHEREAS, the Autauga County Commission has elected to utilize said Qualified List of Engineers and Architects in order to select individual firms to work on specific CDBG projects.

NOW, THEREFORE, BE IT RESOLVED by the Autauga County Commission as follows:

<u>SECTION 1</u>. That the Autauga County Commission desires to utilize the Qualified List of Engineers and Architects, as properly procured and made available by CARPDC, to select the architect needed to perform design and inspection services for CDBG-CV Project No. CV-NC-20-052.

WHEREAS, the Autauga County Commission works to attract and retain economic development; and

WHEREAS, Inteplast Engineered Films Prattville has presented an expansion project to the Autauga County Commission which refers to real property and improvements thereon which is wholly within the Autauga County; and

WHEREAS, said facility shall be equipped for use as an industrial facility for manufacturing engineered films and food grade quality packaging; and

WHEREAS, an abatement was approved in 2018 for an expansion and was unable to be completed due to extenuating circumstances; and

NOW THEREFORE, BE IT RESOLVED, that the Autauga County Commission approves that an incentive package be offered and hereby approves the application from Inteplast Engineered Films Prattville for abatement of all state and local non-educational sales and use taxes except those levied for education purpose and all construction related transaction taxes, except those local construction related transaction taxes levied for education purposes or for capital improvements for education for the specific project as presented in the abatement application.

BE IT FURTHER RESOLVED, that the Autauga County Commission hereby authorizes the Chairman of the Commission to execute for and on behalf of the county commission any and all documents and agreements necessary to offer said incentives and to take all such further action as shall be necessary or desirable to carry out the purposes and intent of this Resolution.
