RESOLUTION #2025-6 RESOLUTION TO ALLOCATE ADDITIONAL AMERICAN RESCUE PLAN ACT FUNDS FOR APPROVED SEWER PROJECT

WHEREAS, Autauga County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, under the Final Rule published by the United States Department of Treasury dated January 6, 2022, the County has duly elected to take the option to designate a standard allowance of up to \$10,000,000 of its ARPA funds, not to exceed the County's total ARPA funds award, as revenue replacement ("Revenue Replacement Funds"); and

WHEREAS, the County may expend designated Revenue Replacement funds for government services, including investments to water and sewer infrastructure; and

WHEREAS, by way of resolution #2023-27, the County previously allocated up to \$6,261,871.00 of ARPA Revenue Replacement Funds to provide for the expansion of a wastewater treatment system along with construction of sanitary sewer service collection line to provide the collection and treatment of wastewater reducing the public health risks associated with privately owned on-site disposal systems and to support increased industrial and residential growth in the Pine Level area (the "Project"); and

WHEREAS, consistent with Alabama Code (1975) §11-88-13, the County may provide funds to a local sewer authority for the purposes of providing improvements to water and sewer systems; and

WHEREAS, consistent with Alabama Code (1975) §11-92A-21, the County may provide funds to a local industrial development authority; and

WHEREAS, in order to realize cost efficiencies, the Project was split into two separate Portions: the construction of a force main and wastewater treatment system bore under I-65 permitting and other administrative functions associated with the project ("Water Main Portion") and the construction of a wastewater treatment plant and pump station no. 1 ("Water System Portion"); and

WHEREAS, in a Funding Agreement dated December 22, 2022, as amended on May 2, 2023, (collectively, the "ACSA Funding Agreement") the Autauga County Commission ("Commission") previously obligated ARPA Revenue Replacement Funds to the Autauga County Sewer Authority ("Sewer Authority"), for the construction of the Water Main Portion, as well as any other professional services necessary for the success of the total Project; and

WHEREAS, due to unforeseen circumstances during the construction of the Water Main Portion, additional work was discovered which was necessary to ensure safe roadways on the project site upon completion; and

WHEREAS, in order to realize cost savings for the additional work, the Commission adopted Resolution 2024-21, allocating funds to the County Highway Department to provide in-kind services, which resulted in costs of materials in the amount of \$3,938.49; and

WHEREAS, in a Funding Agreement dated May 2, 2023, (the "IDA Funding Agreement") the Commission previously obligated ARPA Revenue Replacement Funds to the Autauga County Industrial Development Authority ("IDA") for the construction of the Water System Portion; and

WHEREAS, due to unforeseen circumstances during the construction of both portions of the Project, Change Orders were necessary, which increased construction costs for both the Water Main Portion and Water System Portion of the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County hereby allocates up to \$6,387,163.26 of ARPA funds, designated as Revenue Replacement Funds, to cover reasonable costs relating to the Project. The funds allocated pursuant to this Resolution are inclusive of the funds previously allocated by Resolutions #2023-27 and 2024-21, and shall supersede any other previous resolutions for this Project.
- 2) Of the funds allocated pursuant to this Resolution, \$3,229,218.77 shall be allocated to the Sewer Authority, \$3,154,007.00 shall be allocated to the IDA, and \$3,938.49 shall be allocated to provide for the in-kind services provided by the Highway Department.
- 3) The Commission hereby resolves to amend the ACSA Funding Agreement, in substantially the same format as the Amendment to the Agreement attached hereto as Addendum 1, to increase the obligation to the Sewer Authority by \$39,359.77 to cover change orders for the Water Main Portion.
- 4) The Commission hereby resolves to amend the IDA Funding Agreement, in substantially the same format as the Funding Agreement attached hereto as Addendum 2, to increase the obligation to the IDA by \$81,995.00 to cover a change order for the Water System Portion.
- 5) The Autauga County Commission is hereby authorized to expend these funds as described herein from the designated vendor to facilitate the provision of these services.
- 6) The ARPA Program Director is charged with ensuring that Revenue Replacement funds allocated and expended to provide these government services will not be used in such a way as to frustrate COVID-19 mitigation guidance issued by the Centers for Disease Control, or for any other use prohibited by the Final Rule or any applicable state or federal law.
- 7) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA Revenue Replacement funds for this purpose and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.

IN WITNESS WHEREOF, the Autauga County Commission has caused this Resolution to be executed in its name and on its behalf by its Chairman on the 19th day of November 2024.
