RESOLUTION NO. 2022-7

A RESOLUTION AND ORDER CONFIRMING AND RATIFYING THE LEVY OF THE COUNTYWIDE SCHOOL SALES TAX IN AUTAUGA COUNTY

BE IT RESOLVED AND ORDERED by the Autauga County Commission (the "Commission"), the governing body of Autauga County (the "County"), as follows:

Section 1. Findings. The Commission hereby finds and declares as follows:

- (a) that there is levied in the County, pursuant to Section 40-12-4 of the Code of Alabama 1975, as amended, and Ordinance Nos. 95-17 and 95-18 of the Commission adopted on July special privilege or license tax and excise tax at the basic rate of 1% (together, the "Sales Tax"), the Education (the "Board"); and
- (b) that the Board has reported to the Commission that the Board proposes (i) to issue its Special Tax School Warrants, Series 2021, in the approximate principal amount of \$30,000,000 (the "Warrants"), for the purpose of providing various capital public school improvements in the County, including, without limitation, an early learning center in Prattville, and (ii) to pledge, for the payment of the principal of and interest on the Warrants, so much as is necessary for such purpose of the proceeds of the Sales Tax presently being allocated, apportioned and paid to the Board.

Section 2. <u>Pledge</u>. The County hereby pledges, to the Board and to the registered owners of the Warrants, the Board's allocated or apportioned share of the Sales Tax and agrees that it shall in effect, and to pay the proceeds of the same over to the Board until the final retirement of the Warrants, now expected to occur on or before April 1, 2051, and any obligations of the Board issued to refund the Warrants.
